## 1. Introduction

Today, our society has entered a new stage of development. At a new stage of the country's socio-political and economic life, the people's well-being, human rights and dignity are set as the highest goals. This requires the formation of a completely new spiritual space, a society based on enlightenment. "What is the new spiritual space? In my opinion, it is an enlightened society that clearly reflects the spiritual image of the New Uzbekistan that we dream of, where our people aspire and where our country lives happily. The Strategy of Actions and the Development Strategy of New Uzbekistan adopted by the President of Uzbekistan are five-year "roadmaps" for the implementation of the UN Sustainable Development Goals. In June 2021, the international forum "Global Interparliamentary Cooperation in Achieving Sustainable Development Goals" was held in Bukhara in cooperation with the Inter-Parliamentary Union. We are actively working on the adoption of our initiative by the UN General Assembly in the form of a resolution to "increase the role of parliaments in achieving the goals of sustainable development and ensuring human rights." Uzbekistan was the first among the Central Asian countries to establish a system of national human rights institutions. Parliamentary Ombudsman, Children's Ombudsman, Business Ombudsman and National Center for Human Rights are part of this system.

The state of affairs in the field of elimination of forced and child labor has changed radically. Legislation on improving the national preventive mechanism for prevention of torture was adopted. In response to UN calls to reduce the number of stateless persons, the Law "On Citizenship of the Republic of Uzbekistan" was adopted in 2020, based on which more than 70,000 stateless persons were recognized as citizens of the Republic of Uzbekistan. Congratulating our country on the adoption of the new law "On Citizenship of the Republic of Uzbekistan", UN Secretary General Antonio Guterres said, "Uzbekistan is improving the lives of the vulnerable sections of the population by granting citizenship to previously stateless persons. "This event shows that Uzbekistan is a firm supporter of not leaving a single person alone with an unresolved problem at a time when the world is starting a ten-year effort to achieve the goals in the field of sustainable

development," he noted. At the same time, legislation in our country is being improved taking into account the priority directions of socio-economic development, universally recognized international standards in the field of human rights, as well as the recommendations of UN Charter bodies and treaty committees. Uzbekistan has established effective cooperation and regular dialogue with the Office of the UN High Commissioner for Human Rights. In cooperation with this department, in June 2020, the National Strategy on Human Rights of Uzbekistan was adopted for the first time and is being consistently implemented. It intends to implement the recommendations of the UN Human Rights Council and treaty committees. When adopting the national strategy, not only the opinions of experts, but also the general public and international organizations were taken into account.

The main idea of the New Uzbekistan strategy is to strengthen the role of civil society institutions, protect human rights, reduce poverty, provide everyone with a guaranteed source of income, and achieve sustainable ecological development. The development strategy of New Uzbekistan covers seven priority directions, and in essence, the issue of ensuring spiritual development and bringing the industry to a new level is defined as one of these priority directions. Therefore, it is appropriate to talk about the goals and tasks related to the provision of spiritual development defined in this historical document. "If the body of society is economy, then its soul and spirit is spirituality. As we decided to build a new Uzbekistan, we rely on two strong pillars. The first is a strong economy based on market principles. The second is a strong spirituality based on the rich heritage of our ancestors and national values.

The essence and significance of the speech of the head of our state at this meeting was later reflected in the development strategy of New Uzbekistan. The new development strategy of Uzbekistan consists of "100 goals for human dignity", 8 of which, i.e. goals 71-78, are directly related to issues of spiritual development. The State program for the implementation of the development strategy in 2022 has 398 items, so 29 of them, i.e. items 257-285, are measures related to the field of spirituality. Within the framework of the National Strategy on Human Rights, specific measures have been taken to ensure gender equality, freedom of speech and religion, and the development of civil society institutions, including: The Concept of Civil Society Development in 2021-2025 was approved; A new law "On Freedom of Conscience and Religious Organizations" was adopted; The strategy of achieving gender equality in the Republic of Uzbekistan until 2030 was approved; A Parliamentary Commission was established on compliance with the international obligations of the Republic of Uzbekistan in the field of human rights;

In Uzbekistan, until 2025, the concept of development of the state's youth policy will be implemented, which is based on the principle of "Working with youth for the benefit of youth" stated in the UN "Youth - 2030" strategy.

Institutions of civil society are actively participating in the implementation of the National Strategy on Human Rights. Efforts are being made to strengthen the responsibility of the business community in the field of human rights, including through the development of the "Business and Human Rights" National Action Plan.

Uzbekistan supports intergovernmental processes on strengthening the system of UN treaty bodies on human rights and strives to develop the state's accountability and implement the judgments of treaty bodies. The Republic of Uzbekistan submits its national reports (41 reports) to the treaty bodies of the UN on time. In particular, in February of this year, the Committee for the Elimination of Discrimination against Women heard the Sixth Periodic Report of Uzbekistan, and the Third Periodic Report of the Committee on Economic, Social and Cultural Rights.

It is known that on February 24, 2020, UN Secretary-General A. Guterres put forward the initiative "High Aspiration: Call to Action for Human Rights". One of the most important essences of the "Call" is the need to strengthen civil society, ensure gender equality, achieve equality of men and women in political, economic and social life, as well as freedom of information.

This initiative of the UN is in sync with the reforms implemented by Uzbekistan in the same fields. After all, it is impossible to solve the problems of socio-economic, political-legal and cultural-humanitarian development of the state without ensuring human rights.

The UN Human Rights Council monitors the situation in this area around the world and gives recommendations to the heads of state. Every country that is a member of this international body should be an example in the field of human rights. Uzbekistan, which has joined the Human Rights Council and received recognition, fulfills its obligations responsibly.

Uzbekistan has established regular and effective cooperation with UN human rights protection bodies, especially with the universal periodic review mechanism of the Human Rights Council, which provides equal and non-discriminatory treatment to all countries when assessing their respective human rights situation.

The Development Strategy of New Uzbekistan is a logical continuation of the Action Strategy. In view of the continuation of development changes in a new historical phase, 2 new priority areas were added to the Development Strategy. One of them is related to the provision of spiritual development, and the second is a new priority direction established on the basis of Uzbekistan's response to the global problems occurring in the world.

The main focus of the development strategy is, on the one hand, the adoption of laws, codes, concepts and programs on the development of civil society. We believe that the scope and scale of the current democratic reforms reflected in the development strategy of the new Uzbekistan in the 7 priority directions of the development of our country in the next five years will clarify the real reality.

This important document clearly defines the following goals:

- "establishing a people-friendly state by increasing human dignity and further developing a free civil society;
- making the principles of justice and the rule of law the most basic and necessary condition for development in our country;
- Rapid development of the national economy and ensuring high growth rates;
- Fair social policy, development of human capital;
- ensuring spiritual development and bringing the industry to a new level;
- approach universal problems based on national interests;
- strengthening the security and defense potential of our country, conducting an open pragmatic and active foreign policy.

In general, first in the Strategy of Actions, then in the Strategy of Development, specific tactics and strategies for implementing the UN Sustainable Development Goals in the life of our country, which Uzbekistan undertook to fulfill, were determined.

In other words, Uzbekistan, as an equal member of foreign international relations, was able to develop in line with the UN Sustainable Development Goals and show its unique role and importance, and more importantly, its exemplary experience to the whole world. The new development strategy of Uzbekistan is a proof that this important progressive process continues continuously.

A completely new national legal system is being formed in new Uzbekistan. In this period, the principle that "man, his rights, freedoms, especially his value is the most important value" is recognized.

In this regard, it is necessary to strengthen the principle of "person - society - state" in national legislation and legal practice. After all, the "state-society-man" principle, which has been in effect for years in the development strategy of New Uzbekistan, is being changed to the "man-society-state" principle.

A completely new democratic system for direct communication with the people, positive solutions to the pains, concerns and problems of our compatriots - People's Reception Rooms has justified itself in the past five years. In addition, in the activities of all state bodies, effective work is being done on "listening to people's pain", solving problems on the spot and pleasing the people.

The development strategy of the new Uzbekistan envisages "further improvement of the mechanism of open communication with the people, expansion of the practice of making important decisions taking into account the public opinion, digitization of the process of considering appeals received by state bodies, ensuring quick and high-quality consideration of appeals. Most importantly, the national program "People's State" was developed, which implies the implementation of the idea "The state must serve the people".

Many more examples of large-scale work on the creation of New Uzbekistan can be given in our country. The most important thing is that the growing influence of Uzbekistan in the world today is not only the result of the well-thought-out, strict and independent foreign policy of the state, but also the recognition by the international community of the progress made in the implementation of democratic and market reforms in the country.

The leader of the new Uzbekistan is one of the few politicians of our time who consistently defends the right to go his own way. This is the essence of the path of independent development:

"First, when the specific historical conditions of the society, its national, religious and cultural characteristics are carefully taken into account;

Secondly, in harmony of economic development and progress with traditional moral and cultural values;

Thirdly, in the superiority of common sense over theory not based on experience;

Fourthly, it is evident in the superiority of patriotism, pragmatism and creative practice over ideological concepts.

Raising the value of a person and respecting his honor, rights and freedoms is one of the priorities of the reforms implemented in our country. There are no restrictions on human rights in Uzbekistan based on

nationality, religion, social status, political and other beliefs. The glorification of man, his protection and all-round development are the focus of our large-scale reforms.

The systematic and consistent implementation of the new development strategy of Uzbekistan brings democratic reforms to a new qualitative stage. First of all, this implies the full realization of the priority principle "For human dignity". It should be noted that "human value" is the provision of a peaceful and safe life of citizens, basic rights and freedoms, gradual provision of decent living conditions and creation of modern infrastructure, provision of qualified medical services for every citizen of the country, quality education, social means creating a protective and healthy ecological environment.

First of all, the idea of "New Uzbekistan - a people-oriented and humane state" and the principle of "man - society - state" should be actively implemented in life, the clear distribution of powers between the President, Parliament and the government, mutual restraint and strengthening of balance in the system of separation of powers. , is achieved by developing a free and fair civil society, finding its rightful place in the modern international community.

The formation and development of civil society institutions, parliamentarism, multi-party system is a symbol of real democracy. In the development strategy, comprehensive measures are defined to further increase the role and responsibility of local government authorities in solving local problems, and to transfer most of the state functions from the center to the regions.

In particular, attention is paid to increasing the role of local councils in the development of regions, creating the necessary conditions for the effective functioning of civil institutions. Considering that in 2021 alone, more than 29,000 problems of citizens were positively solved by the local councils, strengthening the constitutional and legal basis of their activity will serve to implement the idea of "People's State" more widely.
