## Are you aware of the National Education Policy 2020? 52 responses





# **3.** Are you aware of the emphasis on vocational education and skill development in NEP 2020? <sup>52</sup> responses





How do you feel about the flexibility offered in choosing subjects and courses in NEP 2020?



How do you feel about the changes proposed in NEP 2020, such as the restructuring of the education system and curriculum?



52 responses







Do you think NEP 2020 could benefit your academic experience as a first-year student? 52 responses


